**Water Co. Report:**

Water Superintendent Derrick Hagan shared the plan is to rebuild the pumps at 55 pump station. The cost for new pumps run between \$60,000 and \$70,000 dollars per pump. To rebuild a pump is around \$25,000 dollars.

John Hammond asked if they provided an estimated time to get these done.

Derrick replied a lot of the materials are coming from Europe – Germany. Depending which vendor, we go with were looking at 16 to 18 weeks or maybe longer.

John then asked, the temporary setup do, you have to go in manually and turn them on. Derrick said they are automatic, but you have to watch it. You have to go in two or three times a day and check the system and fill the fuel up.

Mayor Dudgeon shared several calls came in about people's meter boxes are broken and the lines are freezing at the meter. Citizens are going out trying to unthaw the lines. People need to go into city hall and pay to have the meter lids replaced. Trying to prevent any further damage being done.

**Water/Sewer Rates:**

Mayor Dudgeon shared City of Bardstown is raising both water and sewer rates. Mayor Dudgeon said at this time he did not feel like we needed to raise our water rates, but would need to look at it in the near future. As for the sewer rates, those have not been raised in years, and would need to look at those this summer.

**Property Donated- 158 Depot Street:**

Mayor Dudgeon shared David Case owns a lot on Depot Street. He wants to donate the lot to the city. This lot backs up to the city park.

**Property Sale:**

Mayor Dudgeon shared Audrey is working on the bid package, we will advertise, and hopefully have something to vote on at next council meeting. There was some specific language that needed to be placed in the bid package.

Laura Barnett shared more information about the \$100,000 dollars from the ICE training.


Ken Lemoine wished everyone a Merry Christmas.


Council members Todd Sweazy, Tina Long, and Scott Stevenson had nothing to share.
