

ORDINANCE 2024-1
AN ORDINANCE ADOPTING THE CITY OF BLOOMFIELD KY ANNUAL BUDGET
FOR THE FISCAL YEAR JULY 1, 2024 THRU JUNE 30, 2025

Estimating revenue and resources and appropriating funds for the operation of City Government;

WHEREAS, an annual budget proposal and message has been prepared and delivered to the Bloomfield City Council;
