

**CITY OF BLOOMFIELD
ORDINANCE NO. 2024-4**

***ORDINANCE FIXING THE TAX RATE AND LEVYING AN AD VALOREM TAX
FOR CITY PURPOSES FOR THE FISCAL YEAR 2024-2025 AND PROVIDING HOW THE
FUNDS SO RAISED SHALL BE EXPENDED.***

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLOOMFIELD,
KENTUCKY:**

SECTION I:

There is hereby levied for the tax year **2024** an ad valorem tax of **27.5** cents of each one hundred dollars (\$100.00) of taxable property assessed and assessable of every kind, other than tangible personal property and bank shares, liable to taxation in the City of Bloomfield, Kentucky. There is hereby levied for the tax year **2024** an ad valorem tax of **27.5** cents of each one hundred dollars (\$100.00) of tangible personal property assessed and assessable, liable to taxation in the City of Bloomfield, Kentucky.

SECTION II:

The Nelson County Sheriff prepares the tax bills for all persons and organizations in the City of Bloomfield, Kentucky against whom taxes are levied. Said levy and all **2024** property and tangible taxes are due on or before **December 31, 2024** and become delinquent between **January 1, 2025** and **January 31, 2025** whereby a 5% penalty is assessed. After **January 31, 2025** a 21% penalty is assessed until the close of business **April 15, 2025** after which all unpaid tax bills are transferred from the Sheriff's Department to the County Clerk's Office. The County Clerk will have a sale between July 14 and August 28, 2025 to sell all unpaid delinquent property tax bills.

SECTION III:

There is hereby levied for the tax year beginning **January 1, 2025** an ad valorem tax of **27.5** cents on each one hundred dollars (\$100.00) of fair cash value of motor vehicles assessed and assessable, liable to taxation in the City of Bloomfield. Said tax shall be collected by the Nelson County Court Clerk in accordance with applicable statutes of the Commonwealth of Kentucky.

SECTION IV:

The said levy and all taxes realized there from to be used for and solely devoted to the general municipal purposes and expenses of said City.

SECTION V:

If any section, subsection, sentence, clause or phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holdings shall not affect the validity of the remaining portions hereof.

SECTION VI:

This Ordinance shall take effect upon its second reading, passage and publication.
