Public Comments:

Joe Goodlett provided each of the council members a copy of a police budget. Joe asked the council to consider it for the upcoming fiscal year.

Mayor Dudgeon shared that back in January he had told council the Christmas Parade Committee was going out on their own. They are now ready to do that. Mayor Dudgeon said we need a motion to disband the Christmas Parade Committee.

Mayor Dudgeon went on to say there is \$12,041.48 in the Christmas Parade bank account that was donated to them. I believe the city transfer those funds to them. Judy Wilson made the motion to give the \$12041.48 to the Christmas Parade Committee. Second by Tina Long. By unanimous vote, motion carried.

John Hammond asked all those funds were donations; none of it is city funds. Mayor Dudgeon said all of it is donations. The city did not provide any funds to them.

Paul sent me the steps the city needs to take to go through this process. One of the things Paul recommended we do a GEO Tech testing. John explained what GEO Tech testing is. Paul gave John 3 names of organizations that do Geo testing. John is working on getting quotes from them.

Mayor Dudgeon shared that him and John along with Toni met with some people from Lincoln Trail Area Development District. Toni is working on a grant for the park.

Mayor's Report:

Mayor Dudgeon shared information about upcoming KLC training for the council. Mayor Dudgeon asked Toni to e-mail the council the information about it.

Mayor Dudgeon share information about Pancake Breakfast, Car Show, and JD Shelburne concert events.

Judy Wilson shared the Easter Egg Hunt was a success. She thanked everybody that came out.


Scott, Tina, John, and Todd had nothing to share.
