**Police Department Report:**

Police Chief Eddie Whitworth reported on the following items:

- To date Chief Whitworth has issued approximately 30 citations. The majority of those were for speeding.
- Chief Whitworth shared it was time to renew the Flock Camera software contract. Eddie went on to share how the camera system has help solve a current robbery. After discussion Tina Long made the motion to renew the contract. Second by Todd Sweazy. In a 5 to 1 vote the motion carried; with Laura Barnett being the only no vote.
- Chief Whitworth provided each council member a copy of the City of Alexandria curfew ordinance. Chief Whitworth shared his concerns and how implementing a curfew ordinance would be helpful.

**Board of Adjustment Nominee's:**

Mayor Dudgeon reminded the council we were still looking for a couple of people to serve on the BOA. Laura Barnett said she has asked a couple of people both have denied.
