Police Department Update – Chief Whitworth:

Police Chief Whitworth provided an update on the following topics:

- In the past month thirty-seven tickets have been written.
- Six arrests plus four DUI arrest
- Responded to twelve complaints
- All the items from the grants the Bloomfield PD have been awarded are in. Still waiting to hear back on a couple of grants they applied for.

Park Update – Mayor Dudgeon:

Mayor Dudgeon said the playground company has began putting down the gravel and going to start the rubber curving work tomorrow.

Derrick Hagan said he is still looking into ordering the petitions for the bathrooms and need to order a refrigerator for the concession stand.

Appointment of Presiding Council Member:

Mayor Dudgeon said there is a statue that allows for a council member to serve as the presiding officer at meetings when the mayor is unable to attend. Mayor asked council members if they wanted to vote on somebody or just keep things as they are. After some discussion ken Lemoine made the motion to appoint John Hammond. Second by Laura Barnett.

Council members Todd Sweazy, Tina Long, Laura Barnett, and ken Lemoine voted yes.

John Hammond did not vote. Motion carried, unanimously.

Signage for Cherokee Lane in Blazer Heights Subdivision:

Mayor Dudgeon said prior to the meeting Ken Lemoine reached out to Toni about adding “No Parking” signs on Cherokee Lane. Mayor Dudgeon turned the floor over to Ken to talk about it. Ken said, there is a small turn around space next to Cherokee Lane and people are parking large trucks their and leaving them for extended periods of time. After much discussion, Mayor Dudgeon asked Eddie what the rule is about this. Eddie said he had reached out to the County Attorney and he would not be enforcing parking issues. Ken asked Eddie if it was illegal for people to park there. Eddie said no it is not illegal; however, if HOA had rules they could handle it that way. Ken and Laura both said there is no HOA. After much discussion, Mayor Dudgeon said we would look into posting a sign.

Mayor's Report:
