#### **Police Department Update:**

Police Chief Whitworth shared he has served 35 citations since May's council meeting and he attended the KLC training in Lexington. Day one (1) of the training had to do with Alcohol Beverage Control Licensing and the second day had to do with enforcing city ordinances pertaining to Code Enforcement. Chief Whitworth went on to say he has submitted for, four (4) grants through the Office of Attorney General. Two (2) of them have been through the process and were awarded. We were waiting to hear back from the other two (2).

Scott Stevenson asked what the grants were for. Chief Whitworth said the first grant was for a set of soft body armor, the second set is for hard body armor (rifle plates), the third grant is for a ballistic helmet, and the fourth was for a shield.

#### **Inner Local Agreement:**

Mayor Dudgeon shared Fire Chief Ted Shields had reached out to him about doing an Inner-Local Agreement. Since the fire department allows the city to utilize the fire house without charging and the city does some mowing for the fire department; both the mayor and Ted thought it would be best to get it in writing. Mayor Dudgeon told the council they would not have to vote on it; he just wanted to make them aware.

#### **Resolution 2025-3 Property Sale:**

Laura Barnett made the motion to go into Executive Session. City Attorney, Audrey said, Pursuant to KRS 61.810(1)(b) to discuss the future acquisition or sale of real property.

Second by Ken Lemoine. Motion carried unanimously.

Todd Sweazy made the motion to come out of Executive Session.

Second by Tina Long. Motion carried unanimously.

Tina Long made the motion to approve Resolution 2025-3 Designating Real Property on Hill Street as Surplus Property. Second by Scott Stevenson. In a 4 to 1 vote, motion carried. Laura Barnett was the only member to vote no.
